### Schedule 1

#### **Deliverables**

The Supplier will develop a series of H5P interactive questions that supports the Pressbooks open textbook, and deliver the following:

- An enhanced open textbook in Pressbooks with all H5P interactions integrated with the textbook.
- All H5P questions are pedagogically aligned with content in an existing open textbook.
- All questions must include correct licensing metadata elements, including name of author and Creative Commons licence type.
- Where applicable, questions should include constructive feedback and guidance for learners.
- All H5P interactions will be licensed with a Creative Commons license that allows the reuse and remixing of each element.
- All H5P elements created will be shared to the H5P open repository for reuse.

The Supplier will work closely with BCcampus staff to ensure that the project is on schedule, adheres to licensing agreements, and that the final product is a high-quality instructional resource available for use by educators in British Columbia and elsewhere.

Completed OER materials must include the original, editable files for re-distribution.

OER in the form of multimedia, such as videos, or audio, must be compliant with accessibility standards and include a transcript and, preferably, closed captioning.

OER in the form of written text must be copy edited and proofread to ensure grammatical and spelling accuracy, clarity, and consistency.

**Future Distribution:** BCcampus and the BC Ministry of Advanced Education, Skills & Training will be entitled to distribute the project deliverables under the most current version of the Creative Commons Attribution license.

### **Copyright and Licensing**

# New Creation – copyright with author(s)

The materials covered by this contract will be a newly created work, for which the copyright will be held by the author or in the case of a new creation that is collaboratively produced by more than one author the copyright will be jointly owned by all contributing authors. In both cases, the resulting content will be licensed for reuse with the most current version of the Creative Commons Attribution (CC BY) license. It is the intent of this contract, using grant funds from the Ministry of Advanced Education, Skills and Training through BCcampus, that the resulting materials be widely distributed as open educational resources (OER) with a CC BY license.

## **Use of Existing Content**

Any existing content used in the development of the materials must have a Creative Commons License or be in the public domain. The use of the materials must comply with the original Creative Commons License attributed to the existing content, if applicable.

### **RATES**

- The Supplier will provide a final report after completion of the deliverables; target date for completion of deliverables is November 30, 2020. A reporting template will be provided to the Supplier.

If the Supplier does not fulfill the terms of this agreement, BCcampus has the right to request a refund of some or all of the grant monies awarded.

Payment will only be made upon receipt of invoices. Invoices are to be made out to Simon Fraser University – BCcampus and must include the reference number. Taxes are not applicable.
